I understand there is a small possibility my fingerprint images may be unreadable by BCI&I and I may need to be re-fingerprinted. This is not a reason for a refund since BCI&I charges as soon as the data is transmitted. National Background Check, Inc. will assist with instructions to complete this background check if I am rejected a second time.

I understand that using the WEBCHECK System returns a "no hit" (those containing no criminal history) result within two (2) business days or sooner or a "mailed" result (those that contain a criminal arrest history) in approximately 3-10 business days before being forwarded to the requested destination.

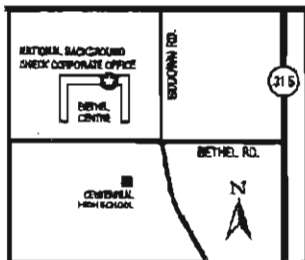
ELECTRONIC FINGERPRINTING PROCEDURES & LOCATIONS

PROCEDURE FOR ELECTRONIC FINGERPRINTING

1. Visit us at www.FastFingerprints.com for online scheduling or call 1-877-932-2435 to schedule an appointment.
2. Arrive at the facility 5 minutes early to fill out a registration form.
3. You will need a valid state or federal identification card (drivers license) and a check, cash, or money order.

BCI only \$35.00 - FBI only \$55.00 - BCI and FBI \$69.00. The results will be mailed from BCI to the location desired.

Call about additional services including Digital Child IDs, fingerprint card scanning, and background investigations.
